- 1. Apologies for absence. Full attendance.
- 2. Declaration of Interests relating to items on the agenda. None declared.
- 3. **Resolved:** Approved the minutes of the GP meeting held on the 17<sup>th</sup> February 2010.
- **4. Information:** Actions arising from GP meeting on the 20<sup>th</sup> January 2010. See agenda.
- **5. Information:** Rock salt bin A selection of bins and suppliers tabled. Noted that the price related to the size of the bin and that a Dark Green was the preferred colour and up to £350 + fitting and delivery, the target price.
